Rental Terms and Conditions

1. **Requirements to hire a buggy.** You must be aged between 21-75 and produce a valid driver's licence which has been held for a minimum of 1 year or more. Faxed or photocopied licences are not acceptable.
2. **Additional drivers.** Must be detailed in the correct section overleaf. The primary driver is responsible for their actions.
3. **What is included in our prices.** Our rates include the cost of the buggy hire, together with third party insurance for the named drivers only, who have completed a booking form.
4. **Period of rental/daily rate calculation.** Our daily rate covers from 9am to 5.45pm on the day of hire. Our weekly rate is for a 7 day period from 9am on the first day to 5.45pm on the last day of hire.
5. **Number of passengers.** Our buggies are insured for a maximum number of 2 persons on a 2 seater, 4 persons on a 4 seater, 6 persons on a 6 seater buggy and 8 persons on a 8 seater buggy only.
6. **Payments.** All charges must be paid for at the time of collection of the buggy by the primary driver.
7. **Charging.** Our buggies are supplied with fully charged batteries. Weekly hired buggies must be plugged in and charged every day after use, even if only used for a short time. Customers who hire a buggy on a weekly rate must be able to park the buggy in a private drive and off the main highway overnight. A full charge takes 8-10 hours to complete. On no account must the charging lead cross a public footpath or pavement. If **The Scilly Cart Co.** hears of any infringement of this very important law they will remove the said buggy and immediately cancel the hire with no refunds being made to the hirer.
8. **Fines/penalties.** Any parking charges/fines etc are the sole responsibility of the hirer. **The Scilly Cart Co.** will pass all information about our hirers to the relevant authorities for them to collect payment. Please note an administration fee of £25.00 will apply.
9. **Provision of vehicle.** **The Scilly Cart Co.** retains the right to refuse to provide a buggy to any customer who appears to be unfit to drive or does not meet eligibility requirements.
10. **Bookings.** **The Scilly Cart Co.** reserves the right to cancel any booking at their own discretion; all bookings are subject to status, availability and terms & conditions.
11. **Early returns.** There is no refund for customers who wish to bring the buggy back early. This is done entirely under the customers will.
12. **Refund.** Any refunds made by **The Scilly Cart Co.** will be paid by cash or card.
13. **Lost keys.** If the buggy key is lost whilst on hire, a replacement key will be provided at a cost of £5.00
14. **Drink/drugs.** **The Scilly Cart Co.** will not be held responsible for any individual whether under the influence of alcohol or drugs or not, causing wilful damage, off road driving or driving on any beach or Duchy/private ground. The hirer will indemnify **The Scilly Cart Co.** against this in respect of all claims.
15. **Mechanical difficulties/accidents.** In the event of an accident or damage to the buggy, you must: (a) Notify **The Scilly Cart Co.** immediately; (b) Not attempt to repair the buggy yourself. In the event of an accident you must also: (a) Obtain a signed police report. (b) Complete an accident form. (c) Obtain details of third parties/witnesses.
16. **Malicious damage.** **The Scilly Cart Co.** will investigate any suspected malicious damage to a buggy, either through avoidable road accidents caused by dangerous driving, or damage to vehicle parts caused via negligence.
17. **Right to drive.** ***Under no circumstances must the buggy be driven off the island's metalled roads.*** Prohibited areas include beaches, farmland and pedestrian pathways and tracks. Repairs for any damage caused by not adhering to this condition will be charged to the hirer together with a call out rate of £25.
18. **Considerations.** Please be aware of other road users: Park considerately and only in permitted areas - the police will issue tickets for illegal parking; Be aware of pedestrians walking in the road - you are driving a quiet vehicle with no engine noise and pedestrians might not hear you coming. Remember; do not use your mobile phone whilst driving the buggy - it is a traffic offence.
19. **Misuse.** A call out charge of £25 will be made for any recovery or repair to a fault or condition caused by the hirer of the buggy. e.g. flat battery, stuck off road or on a beach etc.
